AGREEMENT TO SERVICE TERMS

Last updated September 6, 2021

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and Vedax company limited, doing business as Vedax ("VedaX", "we", "us", or "our"), concerning your access to and use of the <https://link.vedax.ai> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Site"). We are registered in Vietnam and have our registered office at No. 49, Street No. 19, Quarter 5, An Phu Ward, Thu Duc City, , Ho Chi Minh City. Our VAT number is 0304335463. You agree that by accessing the Site, you have read, understood, and agree to be bound by all of these Terms of Use, including the Services Agreement posted on the Site, which are incorporated into these Terms of Use. **IF YOU DO NOT AGREE WITH ALL OF THESE TERMS OF USE, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.**
